## **TREASURER**

Happy 2018 to the Women of the Rappahannock River District UMW! Along with celebrating the New Year, we celebrate successfully reaching our \$40,000 Pledge to Mission. With our continued hard work and giving, we will reach our 2018 District goal of \$40,000 and our Conference goal of \$685,000 in undesignated Mission Giving. It costs 60 cents of undesignated mission giving for 1 second of United Methodist Women mission work with women, children and youth in the United States and around the world.

During fourth quarter, units sent donations directly to The Haven Shelter, ECHO, Healing Eagle Clinic, Henry Fork Service Center, Wesley Community Service Center, Tappahannock Free Clinic and UMC Disaster Tappahannock.

Local units are encouraged to contribute through the 5 channels of Mission Giving - the Pledge to Mission, Gift to Mission, Gift in Memory, Special Mission Recognition and World Thank Offering. If your unit has \$60 for Mission Giving, you can be a 5 Star unit by giving \$5 to Pledge to Mission, \$5 to Gift to Mission, \$5 to Gift in Memory, \$40 to Special Mission Recognition and \$5 to World Thank Offering. If you find you have \$.60 more to give, you can give to the

Virginia Conference 6th channel, Candle-burning, and be a 6 Star unit.

Individuals may contribute to the 5 channels of Mission Giving by becoming a Rainbow Giver. A one-time contribution of \$60 will be divided as above and the individual will be recognized at the District Annual Meeting and presented with a Rainbow Giver pin. In addition, the Rainbow Giver's unit will be a 5 star unit. The form for Rainbow Givers will be sent via email along with this newsletter.

We already have three Six Star Units, eight Five Star Units and two Rainbow Givers for 2018.

All the forms for Treasurers will be sent via email along with this newsletter remittance form: Special Mission Recognition order form, Gift to Mission order form, and supplementary gifts form. If you would like an excel version of the remittance form, please email me.

Anyone sending Legacy Fund donations, please send the donor's name and address with your remittance. If the unit is sending a donation, please include a name and address to send correspondence. This will be sent to the Conference Treasurer, then the National Treasurer and you should get a thank you note, with the signature of the General Secretary and CEO Of United Methodist Women, Harriett Jane Olson.

As a reminder, first quarter remittance is due to me on, or before, March 10. If possible, please include \$4 per member for Administration & Membership Development funds. Please include your unit Pledge to Mission for 2018 (no form required!) with your remittance or via email to jagusty@gmail.com. 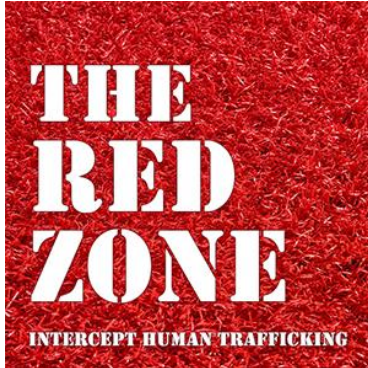
January is **Human Trafficking Awareness Month**, and hopefully your units have been planning your events that are not just confined to January but for throughout the year to promote activism in this area of need.

## HUMAN TRAFFICKING

### Attention: HUMAN Trafficking Legislation 2018

The Virginia Legislature is in session right now and there is some important legislation which you can help support to tighten up the laws previously enacted under Speaker of the House Bill Howell which you ALL helped support. As a result, daily "kingpins" are being taken off the streets and put in jail where they can no longer harm our children! This is a very profitable "business" to the traffickers (second only to the Drug Trafficking) but Human Trafficking is closing in quickly on the Drug epidemic and the profits it generates. Furthermore, SUPER BOWL is approaching rapidly. This is the peak for Human Trafficking, both in the numbers of victims and in the profits for the traffickers.

Legislation being put forth this term in Richmond:

Passed by the House 2017; Awaiting Senate action 2018

**HR2664** Enhancing Detection of Human Trafficking Act would direct the Secretary of Labor to provide training to various Department of Labor personnel in recognizing signs of labor trafficking. This bill has passed the House and is now in the Senate Health, Education, Labor, Pension Committee.

**HR2480** Empowering Law Enforcement to Fight Sex Trafficking Demand would provide federal funding for law enforcement agencies to develop programs for the purpose of fighting sex trafficking. This bill has passed the House and is now in the Senate Committee on the Judiciary.

**HR2200** known as the Frederick Douglass Trafficking Victims Prevention and Protection Reauthorization Act of 2017 will reauthorize funding to stop human trafficking and provide aid to the victims. This bill has passed the House and is now in the Senate Committee on Foreign Relations.

## Senate Bill Status 2018

**S1693** (Stop Enabling Sex Traffickers Act of 2017), is out of committee and will be voted on by the Senate.

Passage of this bill will enable entities to be held liable, such as Backpage.com that advertise victims of sex trafficking.

**HR1865** (Allow States and Victims to Fight Online Sex Trafficking Act of 2017) will hold entities accountable as participants in human trafficking.

I do not have the new bill numbers for 2018 since the Legislature has just begun its session. However, I do have a "rumor" of several bills in the making:

(1) Training of Law Enforcement. Mark Cole from Spotsylvania is signing on with this one.

(2) Criminal records of juvenile victims will be expunged

(3) Children in need of services (both 2 & 3 are David Yancy's bills)

As this information becomes fact, I will keep you informed so you can support these new 2018 bills also.
